EUROPEAN UNION GENERAL DATA PROTECTION REGULATION





Does your organization comply with the new data protection rules?

FutureSoft Solutions believes that it is important for everyone to look after their privacy so please bear with us while we walk you through this update on GDPR - General Data Protection Regulation.

THE GDPR APPLIES TO ORGANIZATIONS ACROSS THE WORLD

Drawn up by the EU, GDPR aims to strengthen the data rights of residents and harmonizes data protection law across all member states, making it identical. At its core, GDPR is a new set of rules designed to give citizens more control over their personal data. It aims to simplify the regulatory environment for business so both citizens and businesses can fully benefit from the digital economy.

We have been preparing for the recent European Union General Data Protection Regulation (GDPR). The GDPR means there are new and updated requirements as to how we process personal data and as such, we have adapted to these changes, implemented them and intend to fully reflect the new legislation. We have always been committed to strict data privacy and security, and will continue to do so with changing laws.

HOW DOES GDPR AFFECT BUSINESS?

This new data protection regulation puts you (the customer) in the driver's seat, and the task of complying with this regulation falls upon businesses and organizations. In short, the GDPR applies to all businesses and organizations established in the EU, regardless of whether the data processing takes place in the EU or not. Even non-EU established organizations would be subject to GDPR. If your business offers goods and/ or services to citizens in the EU, then it is subject to GDPR.

All organizations and companies that work with personal data should appoint a data protection officer or data controller who is in charge of GDPR compliance. Audience might think that the GDPR is just an IT issue, but that is the furthest from the truth. It has broad-sweeping implications for the whole company, including the way companies handle marketing and sales activities.



ENSURING THE RIGHTS OF INDIVIDUALS & CORPORATES

The GDPR recognizes a wide range of rights that an individual or an organization enjoys because of the right to privacy being a fundamental right. Herein listed below are some of the rights afforded under the scheme of the GDPR:

- The Right to Information about the identity of the data controller and the purposed of collection of personal data.
- Right to file a complaint with the supervisory authority.
- Right to be informed of appropriate safeguards undertaken upon transfer of personal data to a third country or international organization
- Right to obtain erasure of personal data concerning the data subject without undue delay, upon satisfaction of certain conditions
- Right to be notified of any rectification, erasure or restriction of processing of personal data in accordance with the above by the controller
- Right to object to processing of personal data.
- Right to transmit the data to another controller without any hindrance.

DATA PROTECTION ASSESSMENT

In the event, where new technology is being used for the purposes of processing, and after having taken account of the nature and scope of the same, it is determined that it is likely to result in high risk to the rights of natural persons, the controller is required to carry out an assessment of the impact on personal data prior to such commencement of processing.


